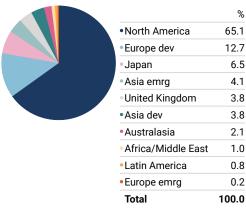

Current Portfolio - Equity Sectors (GICS)





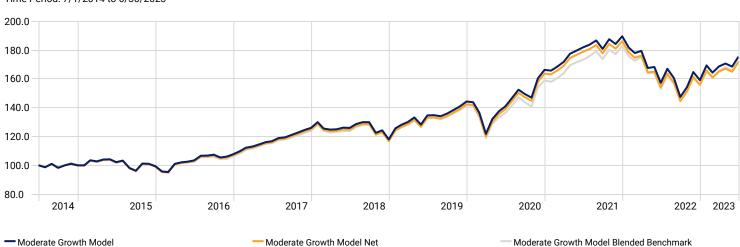
