### **Account protection coverage**

Axos Clearing is a member of the Securities Investor Protection Corporation (SIPC) and provides account protection up to \$100 million for your assets held by Axos Clearing. The first \$500,000 of coverage (including up to \$250,000 for cash balances) per client is provided by SIPC as defined by SIPC Rules ([www.sipc.org](http://www.sipc.org)). Besides our SIPC protection, we also provide additional brokerage insurance through an agreement with Lloyd's of London. Axos Clearing's policy with Lloyd's of London ([www.lloyds.com](http://www.lloyds.com)) provides additional account coverage up to \$99.5 million.

With the combination of SIPC coverage and Lloyd's of London insurance, accounts held by Axos Clearing are protected up to a total of \$100 million per client, including up to \$1.15 million for cash balances with an aggregate limit of \$100 million.

Account protection coverage applies when an SIPC member firm fails financially and is unable to meet its obligations to securities clients. It does not protect against losses from the rise and fall in the market value of investments, and it does not cover all assets. Axos Clearing offers an FDIC-insured sweep account with asset protection up to \$2.5 million.
